

Annual Cases Referred to the Public Prosecution





Annual Cases Referred to the Public Prosecution during 2022





Homicide and Attempted Homicide





Suicide and Attempted Suicide







Bribery & Influence Peddling







The Refrain of Public Officials from Implementing Judicial Verdicts





Forgery of Official Documents





Money Laundering





Misappropriation of Public Funds





Possession of Drugs and Psychotropic Substances







Juvenile Crimes





Domestic Violence Crimes


















